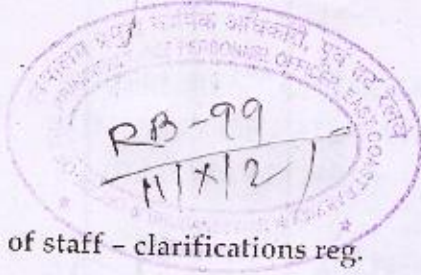


Sub: Periodical Transfer of staff - clarifications reg.


